# Frequently Asked Questions



## Is transitioning to TAE40122 a compliance requirement?

No. It is not a regulatory requirement to complete the TAE40122. However, many RTOs prefer their team to transition to strengthen quality, improve assessment capability, and maintain sector currency.



## Why should I consider transitioning?

Transitioning ensures your skills remain aligned with modern VET practice, including contemporary assessment expectations, digital learning approaches, and improved validation processes. This aligns with the requirements of the Standards for RTO's 2025.



## Does my current TAE qualification count?

Yes. Much of your existing training and experience can be recognised through RPL and assessment mapping.



## How long does the transition take?

Time varies based on evidence, but most trainers complete the process within a short program supported by workshops and guided RPL.



## **What evidence do I need?**

Common evidence includes assessment tools, validation records, training materials, PD logs, your trainer matrix, and workplace documents that demonstrate VET practice.



## **Do I need employer support?**

Employer support is beneficial but not required. SSI can guide you on gathering appropriate evidence.



## **Do I need to attend a classroom-based workshop?**

At SSI we offer three modes for completing the transition to TAE40122. You can do it self-paced online. You can do it by virtual classroom, or you can do it in one of our three-day workshops.



## **Can our whole team attend and get the benefit of consistent understanding of requirements?**
